

## PhD application process at the Chair of African Legal Studies: Step-By-Step Guide

---

The University of Bayreuth is a research-oriented campus located north of the State of Bavaria and is highly ranked for its legal education. The [Chair of African Legal Studies](#) is the hub of training on the Law in Africa at the University. The Chair is unique in Germany as the first permanent Chair to focus on African legal systems.

Do you want to pursue your doctoral studies at the Chair of African Legal Studies? If your answer is affirmative, these steps are essential for you.

### I. Your steps towards a doctorate at the University of Bayreuth

#### Step 1: Examine the PhD requirements

You can access the PhD requirements, including formal and substantial eligibility [here](#). Please make sure to read these requirements carefully. If you meet the formal requirements listed under 2.1. of the requirements, you can proceed.

#### Step 2: Determine your doctoral topic

The initial step toward pursuing a doctorate involves identifying a doctoral topic. This can either stem from an existing research idea or be collaboratively developed with a researcher affiliated with the Chair of African Legal Studies. An applicant needs to prepare a synopsis that serves as a valuable tool to delineate the goals and sub-steps of the research project, aiding in its specification and clarity.

#### Step 3: Develop a PhD proposal

Applicants should develop their research topics and ideas into a proposal. Your proposal should have at least the following elements (see, [3.1.f. Requirements](#)): working title, abstract, introduction/background, problem statement that shows core research questions, overview of key literature, proposed research methodology, feasible timeline, preliminary draft structure and indicative bibliography.

#### Step 4: Find a sustainable financing option

The Chair does not finance PhD studies. It is the individual responsibility of an applicant to apply for and obtain the financing option that can fully sustain their stay and study at the University of Bayreuth. A prospective PhD student may proactively pursue and get a financing option from available scholarship options such as [BIGSAS Scholarship for African Women](#), [German Academic Exchange Service](#) (DAAD), and other [scholarship providers](#). Other options, including those for research stays, are annexed to this application guideline (See Annexure I). Applicants should check their eligibility for any of the options before they apply

### Step 5: Application for Supervision at the Chair of African Legal Studies

The next step is to find a supervisor for your doctoral project. The only eligible supervisor is Prof Dr Thoko Kaime, the holder of the Chair of African Legal Studies. Applications that are made to Prof Kaime must be aligned to the Chair's research areas and interests. You can find an overview of the research areas [here](#) as well as in the [application requirements document](#).

In your application, please include the PhD requirements (under 3.) that you can access [here](#). Please make sure to include all the relevant documents in a single PDF. Incomplete applications cannot be processed.

We aim at assessing your application within one month after the respective deadline that can be found [here](#).

### Step 6: Choice of Doctoral Programme and Responsible Doctoral Institution

The University of Bayreuth has several [faculties](#). With a doctoral application at the Chair for African Legal Studies, typically, the appropriate affiliated institution for doctoral studies is Faculty III, specifically the Faculty of Law, Business and Economics at the University of Bayreuth. ### Step 7: Concluding a supervision agreement with the Chairholder

The next step is to enter into and conclude a formal supervision agreement. The Applicant shall request a draft supervision agreement from the Chair and proceed to fill it in with the required self-explanatory details. The applicant should send the duly filled copy to the Chair of African Legal Studies for signature.

The supervision agreement is a formal document that outlines the terms of the doctoral relationship between the doctoral candidate and the supervisor at the Chair of African Legal Studies. It delineates both parties' respective rights, obligations, and expectations, establishing them in written form. The agreement is an integral part of the formal doctoral process within the Chair and at the University as it serves as a means of quality assurance for the doctoral candidate, the supervisor, and the academic institution involved in the doctoral program.

## Step 8: Enrollment process

Doctoral candidates may enroll for up to three years. There are **three general steps** to enrolment. These are:

## Step 9: Registering as a doctoral student on the BayDOC portal

Once the prospective student has a supervision agreement that is duly signed and dated, the next step is to register digitally at the Faculty for Law, Business & Economics as your doctoral institution. Registration is mandatory according to all doctoral regulations of the University of Bayreuth. During registration, data is collected that must be reported annually on current doctoral projects at the University in accordance with the Act Amending the Higher Education Statistics Act (HStatG) on 2 March 2016.

Requirement for accessing the registration portal is a valid BT-ID (also known as student ID) from the IT Service Centre of the University of Bayreuth. It is also possible to register without a BT-ID. To do so, you need to obtain system access by visiting the following [website](#) and entering your email address, first name, last name, and supervisor name, then submitting as guided in the website.

In either case, the system will send you a confirmation email with a link that you need to click. Once approved, you will be set up as a user and will receive your login credentials (username and password) via email. ## Step 10: Enrolment for doctoral studies on MoveOn Portal

This step comes after receiving the confirmation of supervision from a university lecturer, enrolment as a PhD student. Scholarship providers may sometimes require such an enrollment or to obtain a visa, as you can see [here](#). After successful enrolment, you will receive your student card. This ID will be sent to your registered address. Once you receive it, you should proceed and have it validated at the right-hand machine next to the entrance to the central library 'Zentral Bibliothek'.

### Step 11: Application for acceptance for doctoral studies at the doctoral institution

This application is a process through which an applicant embarks on the formal journey towards obtaining a doctorate. This process requires you to submit your academic and identification documents and all necessary materials to the Dean's Office of the Faculty of Law, Business & Economics. Please note that the forwarding letter has to be in Deutsch. You can use this free translator version if you need to know what to fill out.

### Step 12: Optional – membership of the University of Bayreuth Graduate School

To do so, once you have registered and been accepted for doctoral research by a degree-granting institution (faculty or graduate programme), you may choose to become a member of the University of Bayreuth Graduate School ([UBTGS](#)). UBTGS is an institution open to all doctoral candidates at the University of Bayreuth and supports all doctorates in the faculties, graduate centers and their doctoral programs. It is a support and service institution for general aspects of doctoral training. It offers numerous interdisciplinary workshops in the qualification programme.

All doctoral candidates of the University of Bayreuth can become members of the UBTGS as a central support and funding institution of the University. The UBTGS supports all doctoral candidates with measures such as an individual budget or free qualification programs. However, it is not a degree-granting institution; you cannot get a doctorate through UBTGS.

Please note: You can only apply for membership within 12 months after you have been accepted for a doctorate.
